RESOLUTION NO. 2006-10

WHEREAS, a petition for organization was presented to the Board of Lincoln County Commissioners pursuant to W.S. 18-12-101 et seq. And an election was held on the question of formation of the Alpine Meadows Improvement and Service District ; and

WHEREAS, pursuant to W.S. 22-29-114 (e) the judges of that election have certified the returns of the election to us, the Board of County Commissioners; and

WHEREAS, the judges have certified to us that the votes cast at the election held on March 6, 2006 on the question of organization of the Alpine Meadows Improvement and Service District were as follows:

And that the majority of votes cast at the election are in favor of the organization; and directors as certified to the Board of County Commissioners are:

1. Creed Law to serve a 3 year term
2. Shawn Evans Hawkins to serve a 4 year term
3. Michael T. Halpin to serve a 5 year term

NOW, THEREFORE, BE IT RESOLVED, that the Alpine Meadows Improvement and Service District is hereby declared organized and shall be known with the Corporate name of the Alpine Meadows Improvement and Service District as set forth in the petition and shall be a governmental subdivision of the State of Wyoming and the above named individuals are hereby designated as the first board of directors under the applicable laws of the State of Wyoming.

**IMPORTANT INFORMATION TO NEWLY FORMED DISTRICT:**

**PURSUANT TO WYOMING STATUTE 39-13-102 (p) LEGAL DESCRIPTIONS AND MAPS FOR NEW TAXING ENTITIES – ANY GOVERNMENTAL ENTITY WITH AUTHORITY TO LEVY PROPERTY TAXES WHICH IS FORMED OR ORGANIZED OR WHICH CHANGES ITS GEOGRAPHICAL BOUNDARIES SHALL CAUSE ONE (1) COPY OF THE LEGAL DESCRIPTION AND ONE (1) COPY OF AN OFFICIAL MAP DESIGNATING THE GEOGRAPHICAL BOUNDARIES AS FORMED OR CHANGED TO BE FILED WITH THE DEPARTMENT AND WITH THE COUNTY CLERK AND COUNTY ASSESSOR IN THE COUNTY OR COUNTIES WITHIN WHICH THE ENTITY IS LOCATED WITHIN TEN (10) DAYS FOLLOWING THE EFFECTIVE DATE OF THE FORMATION, ORGANIZATION OR ALTERATION.**
