Results of the election are as follows:


Mike Halpin – 7 votes

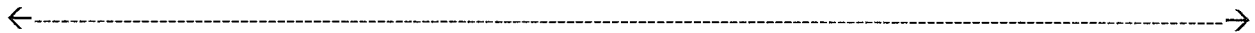
