I. The name of the nonprofit corporation is Alpine Meadows Property Owners Association.

- II. Alpine Meadows Property Owners Association is a mutual benefit corporation.

**VI.** The Corporation will have members.

**VII.** Upon dissolution of the Property Owners Association, the Board of Directors shall provide for the distribution of all assets and liabilities of the Property Owners Association in the following manner:

1. All liabilities and obligations of the Property Owners Association shall be paid and discharged or adequate provisions shall be made thereof;

2. Assets held by the Property Owners Association on condition requiring return, transfer or conveyance, which condition occurs by reason of the dissolution, shall be returned, transferred or conveyed in accordance with such requirements; and

3. Assets received and held by the Property Owners Association after provision for liabilities, conditions or use limitations, as specified in paragraphs 1 and 2 above, shall be

- VIII. In the event of conflict between the provisions of the Declaration of Covenants, Conditions and Restrictions for Alpine Meadows and any supplemental Declarations thereto (the "Declaration") and the provisions of these Articles of Incorporation, the provisions of these Articles of Incorporation shall control.
- IX. The purpose of the Corporation is to conduct the business of a owners association and to engage in any lawful act or activity for which a corporation may be organized under the laws of Wyoming. The Corporation shall be empowered to acquire, rent, lease, let, hold, own, buy, convey, mortgage, bond, sell or assign property, real, personal or mixed, and to borrow money, whether secured or unsecured, and to do and perform all such other acts as are allowed by the laws of the State of Wyoming with respect to nonprofit corporations, as those laws now exist or as they may hereafter provide.
- X. The Corporation shall not afford any pecuniary gain, incidentally or otherwise, to its members, and no part of the net income or net earnings of the Corporation shall inure to the benefit of any member, director, officer, or private person. No substantial part of its activities shall consist of carrying on propaganda or otherwise attempting to influence legislation or intervene in any political campaign on behalf of any candidate for public office. The Corporation shall not lend any of its assets to any officer, director or member of this corporation or guarantee to any other person the payment of a loan mad to an officer, director or member of this corporation.
